#### Quorum

## **Approval of Minutes**

The minutes of the Board meeting held on May 10, 2022 were unanimously approved.

#### **Landscape Maintenance**

Chris Dunn with Perennial Landscape was present to discuss mite damage to the sod around the community and give a monthly update. Perennial will try reseeding the area before the sod replacement option. Perennial Landscape will be implanting a fuel surcharge of \$75.00 a week for mowing due to the rising costs and inflation. They will re-evaulaute after the 15<sup>th</sup> of the month to determine if the charge is still necessary. Water force is on at 100% as of 6/13/2022.
